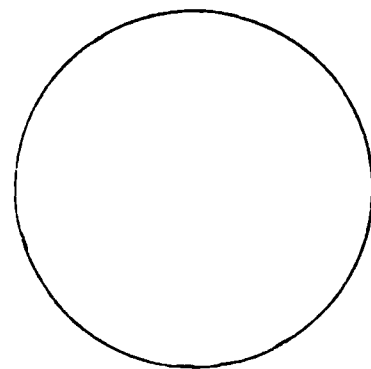

I GEOFFREY ELMER GARRETT of 73 The Strand Walmer Deal in the County of Kent Retired Solicitor HEREBY REVOKE all former Wills and Testamentary Dispositions made by me AND DECLARE this to be my last Will

1. IF MY Wife IVY PHYLLIS GARRETT shall survive me for sixty days I APPOINT her sole Executrix of this my Will and I GIVE DEVISE AND BEQUEATH to her absolutely all my real and personal property whatsoever and wheresoever situate

2. WITHOUT imposing any specific trust upon my said Wife I express the hope that she will do her best to carry out the following wishes :-

- (a) That as and when it shall seem convenient to her she will give to each of my Sons and to my Step-daughter JAN HARTLY MacDONALD the sum of One thousand pounds (£1,000) and to each of my Grand-children and each of the children of the said Jan Hartly MacDonald the sum of One hundred pounds (£100)
- (b) That she will distribute as may seem to her appropriate amongst my Sons such of my purely personal possessions as she shall not require
- (c) That to the extent that at any time she does not wish to retain the use and enjoyment (without being responsible for waste or for replacement) of any of my personal chattels she will distribute them amongst my said Sons and will by her Will or other suitable means ensure that after her death they will be so distributed

(d) That she will make provision by her Will or otherwise for the distribution after her death of such property as she may have inherited from me or which may have derived by any means from property passing to her by reason of this my Will equally among such of my Sons as shall be living at her death provided that if any such Sons shall have predeceased her leaving children living at that date such children will receive equally between them the share which their deceased Father would have received had he survived my said Wife

3. IF MY said Wife shall predecease me or fail to survive me for the said period of sixty days then Clauses 1 and 2 of this my Will shall be of no effect and this my Will shall be construed and take effect as if the said Clauses 1 and 2 had been wholly omitted herefrom and the following Clauses of this my Will shall take effect in lieu of the said Clauses 1 and 2

4. I APPOINT my Sons JOHN PALFREY GARRETT and NICHOLAS YOUNG GARRETT jointly to be Executors and Trustees of this my Will

5. I BEQUEATH the following pecuniary legacies :-

- (a) To each of my Sons the said John Palfrey Garrett and the said Nicholas Young Garrett and Simon Garrett and to my Step-daughter Jan Hartly MacDonald the sum of One thousand pounds (£1,000)
- (b) To each of my Grandchildren and to each of the children of the said Jan Hartly MacDonald living at

my death the sum of One hundred pounds (£100) and
I DECLARE that if at the date of my death any of
such children shall not have attained the age of
eighteen years then the receipt of his or her or
their parent or guardian shall be a full discharge
to my Executors

6. I GIVE all my personal chattels to my said three Sons
jointly and absolutely relying on them to divide or distribute
such articles fairly amongst themselves

7. I GIVE DEVISE and BEQUEATH all the remainder of my real
and personal property of whatsoever kind and wheresoever
situate and not otherwise disposed of by this my Will or by
any Codicil hereto to my Trustees upon trust to sell call in
and convert into money any such part thereof as shall not
consist of money and out of the proceeds thereof and my ready
money to pay my just debts (including any domestic and
personal expenses incurred by or in relation to my said Wife
between the date of my death and hers) and funeral and
testamentary expenses and any taxes arising by reason of my
death and to hold the net residue thereof upon trust for my
said three Sons in equal shares absolutely Provided that in
the event of any of my Sons having died prior to the date of
such distribution the issue of such deceased Son shall take
per stirpes their deceased Father's share of the residue of
my estate and Provided further that any share in respect of
which this trust shall wholly fail shall be added in equal
shares to the shares to be distributed to my remaining Sons
or their issue

8. ANY EXECUTOR or Trustee of this my Will being a Solicit
or other person engaged in any profession or business shall
be entitled to be paid all usual professional or proper
charges for business transacted time expended and acts done
by him or any Partner of his in connection with the trusts
hereof including acts which any Executor of Trustee not being
in any profession or business could have done personally
